- 2. This Offer:
  - Is not valid in conjunction with any other promotion, discount or offer available from either Thrive Homes Pty Limited ACN 613 679 333 (Thrive), or Rawson Communities Pty Limited ACN 003 203 745 (Rawson Communities); and
  - Does not apply to any tenders requested for Medium Density homes or any Rawson Homes Thrive designs.

  - Proceed to sign contract and pay their acceptance fee within 15 days of the contract issue date; and
  - Proceed with the building of an eligible Rawson home.
